Mr. Jefferson faces a long prison term, unless his conviction is overturned on appeal.

As it unfolded over several years, the Jefferson case set off a government battle of constitutional proportions. In May 2006 federal agents raided Mr. Jefferson's Congressional office, the first time that the office of a sitting member of Congress had been searched, leading to an outcry from

some Republicans as well as Democrats. In June 2006, House Democrats voted to remove Mr. Jefferson from the Ways and Means Committee until his case was resolved, but even so, the

investigation became an embarrassment for a party trying to make Republican ethical lapses a major issue in the fall campaign. Mr. Jefferson's constituents were less disturbed, however, and he was

reelected handily that November.
