### Placing links in Wikipedia & proposal for collaboration

Dear Judicial Reform Advocates,

I read with interest the description of your cases of judicial wrongdoing. I would like to suggest that in order for as many people as possible to learn about your cases and help you expose the underlying coordinated judicial wrongdoing that you suffered, you summarize the cases in 350 or fewer words. To that end, I am sending you attached hereto a description of how to do so. The suggestion that I place links in Wikipedia to my website is very much appreciated.

Indeed, if with any realistic chance of success we are to take on the Judiciary and expose the coordinated wrongdoing of its members, we need lawyers and bloggers.

As to the former, we actually need top notch lawyers, for the Judiciary itself is constituted of highly qualified lawyers. In addition, to mount their defense judges have access to the best and the brightest lawyers anywhere. We cannot reasonably expect to be able to deal with them, let alone do so effectively, if we only have among us laypeople-complainants.

As to bloggers, we need them to inform people about the judges' coordinated wrongdoing. Moreover, we need them to get those outraged by such information to take action, that is, (a) to join the *Follow the money!* investigation that searches for more evidence establishing how widespread such wrongdoing is, and (b) to petition their political representatives to launch official investigations of the judiciary and enact judicial reform legislation. Blogging can get people so excited as to create a buzz on the Internet conducive to attaining those objectives.

In a bid for lawyers and bloggers to join judicial reform advocates, I spend an enormous amount of time and effort researching and writing articles of professional quality that will pass muster with lawyers and will persuade bloggers. I need assistance in making those articles reach as many of them as possible.

To that end and in the guise of distribution of labor to further a cause common to all of us, I would like to request:

1. your assistance in placing on my behalf links to my website, namely, <http://Judicial-Discipline-Reform.org> , in as many legal websites and blogs in Wikipedia and elsewhere as possible. Where appropriate, you may use the following description of my website:

Judicial-Discipline-Reform.org is a non-partisan and non-denominational website that advocates judicial reform through legislation.

The need for such reform is established by the legal research and investigative journalism that it has conducted showing evidence of a pattern of judges' acts of disregard for the law, the rules, and the facts pointing to wrongdoing coordinated among judges.

What allows judges to engage in coordinated wrongdoing is their abuse of the system of judicial self-discipline. Indeed, according to official statistics, in the 10-year period 1997-2006, federal judges systematically dismissed the 7,462 complaints filed against them for misconduct or disability and disciplined only 9 of their peers!

These recent facts illustrate what has made it possible that in the 218 years since the creation of the federal judiciary in 1789, the number of federal judges removed from the bench is 7!

As a result of federal judges having exempted themselves from any discipline, they feel free to use their judicial power however they want in the assurance that aside from having a decision reversed, they will suffer no personal adverse consequences. Wielding uncontrolled, and thus absolute power, they have proved true that "power corrupts, and absolute power corrupts absolutely".

To expose the nature and extent of such corruption, Judicial-Discipline-Reform.org has devised and pursues a Watergate-like *Follow the money!* investigative journalism project. 2. your assistance in going to legal websites and blogs to copy their website addresses and from their "Contact Us" page their email addresses and paste them in a table of contact information and send it to me.

I am setting the example by sharing with you the table of contact information of each of the 100 members of the U.S. Senate. You could use a similar format, particularly if you use WORD; otherwise, if you use WordPerfect, you could convert it to WORD before sending it to me so that I can open and continue editing it. Can you send me a copy of your converter?

3. I was stated that after setting links in Wikipedia, the number of hits to the website increased significantly. I would like to detect the number of hits to mine. I have been told that there are free counters and statistics collectors on the Internet that can be set as control panels on one's website and that are invisible to visitors but accessible to the webmaster from his control panel page. Can you help me find a reliable counter and a statistics collector? How do yours work?

I look forward to receiving your suggestions and hope that we can work together to help each other further our common cause of reforming the judiciary in order to bring it closer to its lofty objective of dispensing "Equal Justice Under Law".
