This Table will allow judicial reform advocates to communicate to U.S. House of Representatives their views on the need and petitions for legislative action to set up an effective system requiring federal judges to account for their conduct and administering discipline to them when they engage in misconduct or abuse their enormous judicial power over people's property, liberty, and even life.

Most recently, they have abused their power by drafting procedural rules that will enable them to continue dismissing systematically all misconduct complaints filed against them, thereby self-exempting from any discipline and becoming the only class of persons in our country who as a matter of fact are above the law.
