The contact information on this Table is provided in order to fax and email to each Senator evidence of the need and petitions to replace the present ineffective system of judicial self-discipline with a system, such as one based on a board independent from the judiciary and unrelated to the judges, capable of holding them accountable for their conduct and administering discipline to them as well as making the recommendation for their impeachment and removal from office.

The current newsrelease of Judicial-Discipline-Reform.org is an example of such evidence. It deals with the Revised Rules for processing conduct and disability complaints against judges released by the Committee on Judicial Conduct and Disability of the Judicial Conference of the U.S. It shows how federal judges have abused their judicial power by drafting in self-interest those procedural Rules, which will allow them to continue systematically dismissing every complaint filed against them under the Judicial Conduct and Disability Act, 28 U.S.C. §§351-364, in order to exempt themselves from any discipline.

Indeed, in the 10 year-period 1997-2006 there were 7,462 complaints against judges filed, as required by law, with other judges, who dismissed them and only disciplined 9 of their peers! By dismissing 99.88% of all complaints, judges have in effect abrogated that act of Congress, which ill-advisedly entrusted them with an inherently biased judges-judging-judges system of judicial self-discipline.

how the judges made every effort to keep the Rules from public scrutiny and how the Rules, just as the current ones that they replace, foster the mentality of impunity that leads to more judicial abuse of power and corruption. Hence, they undermine public trust in the integrity of the judges and of judicial process.
